- A purchaser exercising the right to cool off by rescinding the contract forfeits 0.25% of the purchase price of the property to the vendor.
- The vendor is entitled to recover the forfeited amount from an amount paid by the purchaser as a deposit under the contract. The purchaser is entitled to a refund of any balance.

Deposit and other payments before completion 2

The purchaser must pay the deposit to the deposithoider as stakeholder. 2.1

2.2 Normally, the purchaser must pay the deposit on the making of this contract, and this time is essential.

2.3 If this contract requires the purchaser to pay any of the deposit by a later time, that time is also essential.

2.4 The purchaser can pay any of the deposit by -

giving cash (up to \$2,000) to the depositholder; 2.4.1

2.4.2 unconditionally giving a cheque to the depositholder or to the vendor, vendor's agent or vendor's solicitor for sending to the depositholder; or

2.4.3 electronic funds transfer to the depositholder's nominated account and, if requested by the vendor or the depositholder, providing evidence of that transfer.

The vendor can terminate if -2.5

2.5.1 any of the deposit is not paid on time;

2.5.2 a cheque for any of the deposit is not honoured on presentation; or

2.5.3 a payment under clause 2.43 is not received in the depositholder's nominated account by 5.00 pm on the third business day after the time for payment.

This right to terminate is lost as soon as the deposit is paid in full. If the vendor accepts a deposit-bond for the deposit, clauses 2.1 to 2.5 do not apply. 2.6

If the vendor accepts a deposit bond for part of the deposit, clauses 2.1 to 2.5 apply only to the balance.

If any of the deposit or of the balance of the price is paid before completion to the vendor or as the vendor 2.8 directs, it is a charge on the land in favour of the purchaser until termination by the vendor or completion, subject to any existing fight,

If each party tells the depositholder that the deposit is to be invested, the depositholder is to invest the deposit 2.9 (at the risk of the party who becomes entitled to it) with a bank, in an interest-bearing account in NSW, payable at call, with interest to be reinvested, and pay the interest to the parties equally, after deduction of all proper government taxes and financial institution charges and other charges.

3.4.2 it has an expiry date at least three months after its date of issue.

A breach of clauses 3.2 or 3.3 entitles the vendor to terminate. The right to terminate is lost as soon as -3.5 3.5.1 the purchaser serves a replacement deposit-bond; or

the deposit is paid in full under clause 2.

3.6 Clauses 3.3 and 3.4 can operate more than once.

 - normally, the vendor can immediately demand payment from the issuer of the deposit-bond; or 3.10.1

- If the computer systems of the Land Registry are inoperative for any reason at the completion time agreed by 4.13 the parties, and the parties choose that financial settlement is to occur despite this, then on financial settlement occurring
 - all electronic documents Digitally Signed by the vendor and any discharge of mortgage, withdrawal 4.13.1 of caveat or other electronic document forming part of the Lodgment Case for the electronic transaction are taken to have been unconditionally and irrevocably delivered to the purchaser or the purchaser's mortgagee at the time of financial settlement together with the right to deal with the land: and

the vendor is taken to have no legal or equitable interest in the property. 4.13.2

- If the parties do not agree about the delivery before completion of one or more documents or things that 4.14 cannot be delivered through the Electronic Workspace, the party required to deliver the documents or things holds them on completion in escrow for the benefit of; and
 - must immediately after completion deliver the documents or things to, or as directed by; 4.14.2 the party entitled to them.

ĸ Requisitions

- 5.1 If a form of requisitions is attached to this contract, the purchaser is taken to have made those requisitions.
- If the purchaser is or becomes entitled to make any other requisition, the purchaser can make it only by 5.2 servina it
 - if it arises out of this contract or it is a general question about the property or title within 21 days 5.2.1 after the contract date:
 - 5.2.2 if it arises out of anything served by the vendor - within 21 days after the later of the contract date and that service: and
 - 5.2.3 in any other case - within a reasonable time.

6 Error or misdescription

- Normally, the purchaser can (but only before completion) claim compensation for an error or misdescription in this contract (as to the *property*, the title or anything else and whether substantial or not). This clause applies even if the purchaser did not take notice of or rely on anything in this contract containing 6.1
- 6.2 or giving rise to the error or misdescription.
- 6.3 However, this clause does not apply to the extent the purchaser knows the true position.

7 Claims by purchaser

Normally, the purchaser can make a claim (including a claim under clause 6) before completion only by serving it with a statement of the amount elaimed, and if the purchaser makes one or more claims before completion -

- 7.1 the vendor can rescind if in the case of claims that are not claims for delay -
 - 7.1.1
 - 7.1.2
 - the total amount claimed exceeds 5% of the price; the vendor serves notice of intention to rescind; and the purchaser does not serve notice waiving the claims within 14 days after that service; and 7.1.3
- 7.2
- if the vendor does not rescind, the parties must complete and if this contract is completed —

 7.2.1 the lesser of the total amount claimed and 10% of the price must be paid out of the price to and held by the depositholder until the claims are finalised or lapse;
 - 7.2.2 the amount held is to be invested in accordance with clause 2.9;
 - the claims must be finalised by an arbitrator appointed by the parties or, if an appointment is not 7.2.3 made within I month of completion, by an arbitrator appointed by the President of the Law Society at the request of a party (in the latter case the parties are bound by the terms of the Conveyancing Arbitration Rules approved by the Law Society as at the date of the appointment);
 - the purchaser is not entitled, in respect of the claims, to more than the total amount claimed and 7,2,4 the costs of the purchaser:
 - 7.2.5 net interest on the amount held must be paid to the parties in the same proportion as the amount held is paid; and
 - 7.2.6 if the parties do not appoint an arbitrator and neither party requests the President to appoint an arbitrator within 3 months after completion, the claims lapse and the amount belongs to the vendor.

Vendor's rights and obligations

- 8.1 The vendor can rescind if -
 - 8.1.1 the vendor is, on reasonable grounds, unable or unwilling to comply with a requisition;
 - the vendor serves a notice of intention to rescind that specifies the requisition and those grounds; 8.1.2
 - 8.1.3 the purchaser does not serve a notice waiving the requisition within 14 days after that service.

- If the vendor does not comply with this contract (or a notice under or relating to it) in an essential respect, the 8.2 purchaser can terminate by serving a notice. After the termination
 - the purchaser can recover the deposit and any other money paid by the purchaser under this 8.2.1 contract:
 - the purchaser can sue the vendor to recover damages for breach of contract; and 8.2.2
 - if the purchaser has been in possession a party can claim for a reasonable adjustment. 8.2.3

9 Purchaser's default

If the purchaser does not comply with this contract (or a notice under or relating to it) in an essential respect, the vendor can terminate by serving a notice. After the termination the vendor can -

- keep or recover the deposit (to a maximum of 10% of the price); 9.1
- hold any other money paid by the purchaser under this contract as security for anything recoverable under this 9.2 clause
 - for 12 months after the termination; or 9.2.1
 - If the vendor commences proceedings under this clause within 12 months, until those proceedings 9.2.2 are concluded: and
- sue the purchaser either -9.3
 - where the vendor has resold the property under a contract made within 12 months after the 9.3.1 termination, to recover -
 - the deficiency on resale (with credit for any of the deposit kept or recovered and after allowance for any capital gains tax or goods and services tax payable on anything recovered under this clause); and
 - the reasonable costs and expenses arising out of the purchaser's non-compliance with this contract or the notice and of resale and any attempted resale; or
 - 9.3.2 to recover damages for breach of contract.

Restrictions on rights of purchaser

- The purchaser cannot make a claim or requisition of rescind or terminate in respect of -10.1
 - the ownership or location of any fence as defined in the Dividing Fences Act 1991; 10.1.1
 - a service for the property being a joint service or passing through another property, or any service 10.1.2 for another property passing through the property ('service' includes air, communication, drainage, electricity, garbage, gas, oil, radio, sewerage, telephone, television or water service);
 - a wall being or not being a party wall in any sense of that term or the *property* being affected by an easement for support or not having the benefit of an easement for support; 10.1.3
 - 10.1.4
 - any change in the *property* due to fair wear and tear before completion; a promise, representation or statement about this contract, the *property* or the title, not set out or 10.1.5 referred to in this contracts
 - a condition, exception, reservation or restriction in a Crown grant; 10.1.6
 - the existence of any authority or licence to explore or prospect for gas, minerals or petroleum; 10.1.7
 - any easement or restriction on use the substance of either of which is disclosed in this contract or 10.1.8 any non-compliance with the easement or restriction on use; or
 - anything the substance of which is disclosed in this contract (except a caveat, charge, mortgage, 10.1.9 priority notice or writ).
- The purchaser cannot rescind or terminate only because of a defect in title to or quality of the inclusions. 10.2
- Normally, the purchase cannot make a claim or requisition or rescind or terminate or require the vendor to 10.3 change the nature of the title disclosed in this contract (for example, to remove a caution evidencing qualified title, or to lodge a plan of survey as regards limited title).

Compliance with work orders 11

- Normally, the vendor must by completion comply with a work order made on or before the contract date and if 11.1 this contract is completed the purchaser must comply with any other work order.
- If the purchaser complies with a work order, and this contract is rescinded or terminated, the vendor must pay 11.2 the expense of compliance to the purchaser.

12 Certificates and inspections

- The vendor must do everything reasonable to enable the purchaser, subject to the rights of any tenant -
- to have the property inspected to obtain any certificate or report reasonably required; 12.1
- to apply (if necessary in the name of the vendor) for -12.2
 - any certificate that can be given in respect of the property under legislation; or 12.2.1
 - a copy of any approval, certificate, consent, direction, notice or order in respect of the property 12.2.2 given under legislation, even if given after the contract date; and
- to make 1 inspection of the property in the 3 days before a time appointed for completion. 12.3

- 13 Goods and services tax (GST)
- Terms used in this clause which are not defined elsewhere in this contract and have a defined meaning in the 13.1 GST Act have the same meaning in this clause.
- 13.2 Normally, if a party must pay the price or any other amount to the other party under this contract, GST is not to be added to the price or amount.
- 13.3 If under this contract a party must make an adjustment or payment for an expense of another party or pay an expense payable by or to a third party (for example, under clauses 14 or 20.7)
 - the party must adjust or pay on completion any GST added to or included in the expense; but 13.3.1
 - 13.3.2 the amount of the expense must be reduced to the extent the party receiving the adjustment or payment (or the representative member of a GST group of which that party is a member) is entitled to an input tax credit for the expense; and
 - If the adjustment or payment under this contract is consideration for a taxable supply, an amount 13.3.3 for GST must be added at the GST rate.
- 13.4 If this contract says this sale is the supply of a going concern -
 - 13,4,1
 - the parties agree the supply of the property is a supply of a going concern; the vendor must, between the contract date and completion carry on the enterprise conducted on 13.4.2 the land in a proper and business-like way;
 - 13.4.3 if the purchaser is not registered by the date for completion, the parties must complete and the purchaser must pay on completion, in addition to the price, an amount being the price multiplied by the GST rate ("the retention sum"). The retention sum is to be held by the depositholder and dealt with as follows
 - if within 3 months of completion the purchaser serves a letter from the Australian Taxation Office stating the purchaser is registered with a date of effect of registration on or before completion, the depositholder is to pay the retention sum to the purchaser; but
 - if the purchaser does not serve that letter within 3 months of completion, the depositholder is to pay the retention sum to the vendor; and
 - 13.4.4 if the vendor, despite clause 13.4.1, serves a letter from the Australian Taxation Office stating the vendor has to pay GST on the supply, the purchaser must pay to the vendor on demand the amount of GST assessed.
- Normally, the vendor promises the margin scheme will not apply to the supply of the property. 13.5
- 13.6 If this contract says the margin scheme is to apply in making the taxable supply, the parties agree that the margin scheme is to apply to the sale of the property.
- 13.7 If this contract says the sale is not a taxable supply
 - the purchaser promises that the property will not be used and represents that the purchaser does not intend the property (or any part of the property) to be used in a way that could make the sale a 13.7.1 taxable supply to any extent; and
 - 13.7.2 the purchaser must pay the vendor on completion in addition to the price an amount calculated by multiplying the price by the GST rate if this sale is a taxable supply to any extent because of –

 • a breach of clause 43.7.1; or

 - something else known to the purchaser but not the vendor.
- If this contract says this sale is a taxable supply in full and does not say the margin scheme applies to the 13.8 property, the vendor must pay the purchaser on completion an amount of one-eleventh of the price if -13.8.1 this sale is not a taxable supply in full; or
 - 13.8.2 the margin scheme applies to the property (or any part of the property).
- 13.9 If this contract says this sale is a taxable supply to an extent -
 - 13.9.1 clause 13.7.1 does not apply to any part of the property which is identified as being a taxable supply; and
 - 13.9.2 the payments mentioned in clauses 13.7 and 13.8 are to be recalculated by multiplying the relevant payment by the proportion of the price which represents the value of that part of the property to which the clause applies (the proportion to be expressed as a number between 0 and 1). Any evidence of value must be obtained at the expense of the vendor.
- 13.10 Normally, on completion the vendor must give the recipient of the supply a tax invoice for any taxable supply by the vendor by or under this contract.
- 13.11 The vendor does not have to give the purchaser a tax invoice if the margin scheme applies to a taxable supply.
- If the vendor is liable for GST on rents or profits due to issuing an invoice or receiving consideration before 13,12 completion, any adjustment of those amounts must exclude an amount equal to the vendor's GST liability.
- If the vendor serves details of a GSTRW payment which the purchaser must make, the purchaser does not 13.13 have to complete earlier than 5 business days after that service and clause 21.3 does not apply to this provision.
- 13,14 If the purchaser must make a GSTRW payment the purchaser must, at least 2 business days before the date for completion, serve evidence of submission of a GSTRW payment notification form to the Australian Taxation Office by the purchaser or, if a direction under either clause 4.8 or clause 30.4 has been given, by the transferee named in the transfer the subject of that direction.

- 14 Adjustments
- 14.1 Normally, the vendor is entitled to the rents and profits and will be liable for all rates, water, sewerage and drainage service and usage charges, land tax, levies and all other periodic outgoings up to and including the adjustment date after which the purchaser will be entitled and liable.
- 14.2 The parties must make any necessary adjustment on completion, and -
 - 14.2.1 the purchaser must provide the vendor with adjustment figures at least 2 business days before the date for completion; and
 - 14.2.2 the vendor must confirm the adjustment figures at least 1 business day before the date for completion.
- If an amount that is adjustable under this contract has been reduced under legislation, the parties must on 14.3 completion adjust the reduced amount.
- 14.4 The parties must not adjust surcharge land tax (as defined in the Land Tax Act 1956) but must adjust any other land tax for the year current at the adjustment date -
 - 14.4.1 only if land tax has been paid or is payable for the year (whether by the vendor or by a predecessor in title) and this contract save that land tax is adjustable:
 - by adjusting the amount that would have been payable if at the start of the year -14.4.2

 - the person who owned the land owned no other land; the land was not subject to a special trust or owned by a non-concessional company; and
 - if the land (or part of it) had no separate taxable value, by calculating its separate taxable value on a proportional area basis.
- 14.5 The parties must not adjust any first home buyer choice property tax:
- 14.6 If any other amount that is adjustable under this contract relates partly to the land and partly to other land, the parties must adjust it on a proportional area basis.
- If on completion the last bill for a water, sewerage or drainage usage charge is for a period ending before the 14.7 adjustment date, the vendor is liable for an amount calculated by dividing the bill by the number of days in the period then multiplying by the number of unbilled days up to and including the adjustment date. -
- 14.8 The vendor is liable for any amount recoverable for work-started on or before the contract date on the property or any adjoining footpath or road.

15 Date for completion

The parties must complete by the date for completion and, if they do not, a party can serve a notice to complete if that party is otherwise entitled to do so.

16 Completion

Vendor

- Normally, on completion the vendor must cause the legal title to the property (being the estate disclosed in this 16.1 contract) to pass to the purchaser free of any charge, mortgage or other interest, subject to any necessary registration.
- The legal title to the property does not pass before completion. 16.2
- If the vendor gives the purchaser a document (other than the transfer) that needs to be lodged for registration, 16.3 the vendor must pay the lodgment fee to the purchaser.
- If a party serves a land tax certificate showing a charge on any of the land, by completion the vendor must do 16.4 all things and pay all money required so that the charge is no longer effective against the land.

Purchaser

- On completion the purchaser must pay to the vendor 16.5.1 the price less any 16.5
 - - deposit paid:
 - FRCGW remittance payable:
 - GSTRW payment; and
 - amount payable by the vendor to the purchaser under this contract; and

any other amount payable by the purchaser under this contract. 16.5.2

- 16.6 If any of the deposit is not covered by a deposit-bond, at least 1 business day before the date for completion the purchaser must give the yendor an order signed by the purchaser authorising the depositholder to account to the vendor for the deposit, to be held by the vendor in escrow until completion.
- On completion the deposit belongs to the vendor. 16.7

17

- 17.1 Normally, the vendor must give the purchaser vacant possession of the property on completion.
- 17.2 The vendor does not have to give vacant possession if
 - this contract says that the sale is subject to existing tenancies; and 17.2.1
 - the contract discloses the provisions of the tenancy (for example, by attaching a copy of the lease 17.2.2 and any relevant memorandum or variation).
- 17.3 Normally, the purchaser can claim compensation (before or after completion) or rescind if any of the land is affected by a protected tenancy (a tenancy affected by Schedule 2, Part 7 of the Residential Tenancies Act 2010).

- 18 Possession before completion
- This clause applies only if the vendor gives the purchaser possession of the property before completion. 18.1
- 18.2 The purchaser must not before completion
 - let or part with possession of any of the property; 18.2.1
 - make any change or structural alteration or addition to the property; or 18.2.2
 - contravene any agreement between the parties or any direction, document, legislation, notice or 18.2.3 order affecting the property.
- 18.3 The purchaser must until completion
 - keep the property in good condition and repair having regard to its condition at the giving of 18.3.1 possession; and
 - allow the vendor or the vendor's authorised representative to enter and inspect it at all reasonable 18.3,2 times.
- The risk as to damage to the property passes to the purchaser immediately after the purchaser enters into 18.4 possession.
- If the purchaser does not comply with this clause, then without affecting any other right of the vendor the vendor can before completion, without notice, remedy the non-compliance; and 18.5
 - if the vendor pays the expense of doing this, the purchaser must pay it to the vendor with interest at the rate prescribed under s101 Civil Procedure Act 2005. (
- If this contract is rescinded or terminated the purchaser must immediately vacate the property. 18.6
- If the parties or their solicitors on their behalf do not agree in writing to a fee or rent, none is payable. 18.7

19 Rescission of contract

- 19.1 If this contract expressly gives a party a right to rescind, the party can exercise the right -19.1.1 only by serving a notice before completion; and
 - in spite of any making of a claim or requisition, any attempt to satisfy a claim or requisition, any 19.1.2 arbitration, litigation, mediation or negotiation of any giving or taking of possession.
- Normally, if a party exercises a right to rescind expressly given by this contract or any legislation the deposit and any other money paid by the purchaser under this contract must be refunded; 19.2
 - 19.2.2
 - a party can claim for a reasonable adjustment if the purchaser has been in possession; a party can claim for damages, costs of expenses arising out of a breach of this contract; and a party will not otherwise be liable to pay the other party any damages, costs or expenses. 19.2,3
 - 19.2.4

20 Miscellaneous

- The parties acknowledge that anything stated in this contract to be attached was attached to this contract by 20.1 the vendor before the purchaser signed, it and is part of this contract. 20.2
- Anything attached to this contract is part of this contract.
- An area, bearing or dimension in this contract is only approximate. 20.3
- If a party consists of 2 or more persons, this contract benefits and binds them separately and together. 20.4
- A party's solicitor can receive any amount payable to the party under this contract or direct in writing that it is 20.5 to be paid to another person.
- 20.6 A document under or relating to this contract is -
 - 20.6.1 signed by a party if it is signed by the party or the party's solicitor (apart from a direction under clause 4.8 or clause 30.4);
 - 20.6.2 served if it is served by the party or the party's solicitor;
 - 20.6.3 served if it is served on the party's solicitor, even if the party has died or any of them has died; 20.6.4
 - served if it is served in any manner provided in s170 of the Conveyancing Act 1919;
 - served if it is sent by email or fax to the party's solicitor, unless in either case it is not received; 20.6.5 20.6.6
 - served on a person if it (or a copy of it) comes into the possession of the person; 20.6.7
 - served at the earliest time it is served, if it is served more than once; and 20.6.8
 - served if it is provided to or by the party's solicitor or an authorised Subscriber by means of an Electronic Workspace created under clause 4. However, this does not apply to a notice making an obligation essential, or a notice of rescission or termination.
- An obligation to pay an expense of another party of doing something is an obligation to pay --20.7 if the party does the thing personally - the reasonable cost of getting someone else to do it; or 20.7.1 20.7.2
- if the party pays someone else to do the thing the amount paid, to the extent it is reasonable. Rights under clauses 4, 11, 13, 14, 17, 24, 30 and 31 continue after completion, whether or not other rights 20.8 continue.
- The vendor does not promise, represent or state that the purchaser has any cooling off rights. 20.9
- The vendor does not promise, represent or state that any attached survey report is accurate or current.
- A reference to any legislation (including any percentage or rate specified in legislation) is also a reference to 20.11 any corresponding later legislation.
- Each party must do whatever is necessary after completion to carry out the party's obligations under this 20.12 contract.
- 20.13 Neither taking possession nor serving a transfer of itself implies acceptance of the property or the title.

- The details and information provided in this contract (for example, on pages 1 4) are, to the extent of each party's knowledge, true, and are part of this contract.
- Where this contract provides for choices, a choice in BLOCK CAPITALS applies unless a different choice is 20.15 marked.
- Each party consents to -20.16
 - any party signing this contract electronically; and 20.16.1
 - the making of this contract by the exchange of counterparts delivered by email, or by such other 20.16.2 electronic means as may be agreed in writing by the parties.
- Each party agrees that electronic signing by a party identifies that party and indicates that party's intention to 20.17 be bound by this contract.
- Time limits in these provisions 21
- If the time for something to be done or to happen is not stated in these provisions, it is a reasonable time. 21.1
- If there are conflicting times for something to be done or to happen, the latest of those times applies. 21.2
- The time for one thing to be done or to happen does not extend the time for another thing to be done or to 21.3
- If the time for something to be done or to happen is the 29th, 30th or 3 tst day of a month, and the day does 21.4 not exist, the time is instead the last day of the month.
- If the time for something to be done or to happen is a day that is not a business day, the time is extended to 21.5 the next business day, except in the case of clauses 2 and 3.2.
- Normally, the time by which something must be done is fixed but not essential. 21.6
- Foreign Acquisitions and Takeovers Act 1975 22
- The purchaser promises that the Commonwealth Treasurer cannot prohibit and has not prohibited the transfer 22.1 under the Foreign Acquisitions and Takeovers Act 1975.
- This promise is essential and a breach of it entitles the vendor to terminate. 22.2
- Strata or community title 23
 - Definitions and modifications
- This clause applies only if the land (or part of it) is a lot in a strata, neighbourhood, precinct or community 23.1 scheme (or on completion is to be a lot in a scheme of that kind).
- In this contract -23.2
 - 'change', in relation to a scheme, means 23.2.1
 - a registered or registrable offange from by-laws set out in this contract;
 - a change from a development or management contract or statement set out in this contract; or
 - a change in the boundaries of common property;
 - 'common property' includes association property for the scheme or any higher scheme; 23.2.2
 - 'contribution' includes an amount payable under a by-law; 23.2.3
 - 'information certificate' includes a certificate under s184 Strata Schemes Management Act 2015 23.2.4 and s171 Community Land Management Act 2021;
 - 'interest notice' includes a strata interest notice under s22 Strata Schemes Management Act 2015 23.2.5
 - and an association interest notice under s20 Community Land Management Act 2021; 'normal expenses', in relation to an owners corporation for a scheme, means normal operating 23.2.6 expenses usually payable from the administrative fund of an owners corporation for a scheme of the same kind;
 - 'owners corporation' means the owners corporation or the association for the scheme or any higher 23.2.7 scheme:
 - 'the property' includes any interest in common property for the scheme associated with the lot; and 23.2.8
 - 'special expenses', in relation to an owners corporation, means its actual, contingent or expected 23,2.9 expenses, except to the extent they are
 - normal expenses;
 - due to fair wear and tear;
 - disclosed in this contract; or
 - covered by moneys held in the capital works fund.
- Clauses 11, 14.8 and 18.4 do not apply to an obligation of the owners corporation, or to property insurable by 23.3
- Clauses 14.4.2 and 14.6 apply but on a unit entitlement basis instead of an area basis. 23.4
 - Adjustments and liability for expenses
- The parties must adjust under clause 14.1 -23.5
 - a regular periodic contribution; 23.5.1
 - a contribution which is not a regular periodic contribution but is disclosed in this contract; and 23.5.2
 - on a unit entitlement basis, any amount paid by the vendor for a normal expense of the owners 23.5.3 corporation to the extent the owners corporation has not paid the amount to the vendor.

- If a contribution is not a regular periodic contribution and is not disclosed in this contract -23.6 23.6.1
 - the vendor is liable for it if it was determined on or before the contract date, even if it is payable by instalments; and
 - the purchaser is liable for all contributions determined after the contract date. 23.6.2
- The vendor must pay or allow to the purchaser on completion the amount of any unpaid contributions for 23.7 which the vendor is liable under clause 23.6.1.
- Normally, the purchaser cannot make a claim or requisition or rescind or terminate in respect of 23.8 23.8.1 an existing or future actual, contingent or expected expense of the owners corporation;
 - a proportional unit entitlement of the lot or a relevant lot or former lot, apart from a claim under 23.8,2 clause 6: or
 - a past or future change in the scheme or a higher scheme. 23.8.3
- 23.9 However, the purchaser can rescind if
 - the special expenses of the owners corporation at the later of the contract date and the creation of 23.9.1 the owners corporation when calculated on a unit entitlement basis (and, if more than one lot or a higher scheme is involved, added together), less any contribution paid by the vendor, are more than 1% of the price:
 - 23.9.2 in the case of the lot or a relevant lot or former lot in a higher scheme, a proportional unit entitlement for the lot is disclosed in this contract but the lot has a different proportional unit entitlement at the contract date or at any time before completion;
 - a change before the contract date or before completion in the scheme or a higher scheme 23.9.3 materially prejudices the purchaser and is not disclosed in this contract; or
 - a resolution is passed by the owners corporation before the contract date or before completion to 23.9.4 give to the owners in the scheme for their consideration a strata renewal plan that has not lapsed at the contract date and there is not attached to this contract a strata renewal proposal or the strata renewal plan.

Notices, certificates and inspections

- Before completion, the purchaser must serve a copy of an interest notice addressed to the owners corporation 23.10 and signed by the purchaser.
- After completion, the purchaser must insert the date of completion in the interest notice and send it to the 23.11 owners corporation. 23.12
- The vendor can complete and send the interest notice as agent for the purchaser.
- The vendor must serve at least 7 days before the date for completion, an information certificate for the lot, the 23.13
- scheme or any higher scheme which relates to a period in which the date for completion falls. The purchaser does not have to complete earlier than 7 days after *service* of the information certificate and clause 21.3 does not apply to this provision. On completion the purchaser must pay the vendor the prescribed 23.14 fee for the information certificate.
- 23,15
- The vendor authorises the purchaser to apply for the purchaser's own information certificate.

 The vendor authorises the purchaser to apply for and make an inspection of any record or other document in the custody or control of the owners corporation or relating to the scheme or any higher scheme. Meetings of the owners corporation
- If a general meeting of the owners corporation is convened before completion -23.17
 - if the vendor receives notice of it, the vendor must immediately notify the purchaser of it; and 23,17,1 after the expiry of any cooling off period, the purchaser can require the vendor to appoint the 23.17.2
 - purchaser (or the purchaser's nominee) to exercise any voting rights of the vendor in respect of the lot at the meeting.

24 **Tenancies**

- If a tenant has not made a payment for a period preceding or current at the adjustment date -24.1 for the purposes of clause 14.2, the amount is to be treated as if it were paid; and 24.1.1
 - the purchaser assigns the debt to the vendor on completion and will if required give a further 24.1,2 assignment at the vendor's expense.
- If a tenant has paid in advance of the adjustment date any periodic payment in addition to rent, it must be 24.2 adjusted as if it were rent for the period to which it relates. 24.3
- If the property is to be subject to a tenancy on completion or is subject to a tenancy on completion the vendor authorises the purchaser to have any accounting records relating to the tenancy 24.3.1
 - inspected and audited and to have any other document relating to the tenancy inspected; 24.3.2 the vendor must serve any information about the tenancy reasonably requested by the purchaser before or after completion; and
 - normally, the purchaser can claim compensation (before or after completion) if -24.3.3
 - a disclosure statement required by the Retail Leases Act 1994 was not given when required;
 - such a statement contained information that was materially false or misleading;
 - a provision of the lease is not enforceable because of a non-disclosure in such a statement; or
 - the lease was entered into in contravention of the Retail Leases Act 1994.

- If the property is subject to a tenancy on completion -24.4
 - the vendor must allow or transfer -24.4.1
 - any remaining bond money or any other security against the tenant's default (to the extent the security is transferable):
 - any money in a fund established under the lease for a purpose and compensation for any money in the fund or interest earnt by the fund that has been applied for any other purpose;
 - any money paid by the tenant for a purpose that has not been applied for that purpose and compensation for any of the money that has been applied for any other purpose;
 - if the security is not transferable, each party must do everything reasonable to cause a replacement 24.4.2 security to issue for the benefit of the purchaser and the vendor must hold the original security on trust for the benefit of the purchaser until the replacement security issues;
 - the vendor must give to the purchaser -24.4.3
 - at least 2 business days before the date for completion, a proper notice of the transfer (an attornment notice) addressed to the tenant, to be held by the purchaser in escrow until completion:
 - any certificate given under the Retail Leases Act 1994 in relation to the tenancy;
 - a copy of any disclosure statement given under the Retail/Leases Act 1994;
 - a copy of any document served on the tenant under the lease and written details of its service, if the document concerns the rights of the landlord of the tenant after completion; and
 - any document served by the tenant under the lease, and written details of its service, if the document concerns the rights of the landlord of the tenant after completion;
 - the vendor must comply with any obligation to the tenant under the lease, to the extent it is to be 24.4.4 complied with by completion; and
 - the purchaser must comply with any obligation to the tenant under the lease, to the extent that the 24.4.5 obligation is disclosed in this contract and is to be complied with after completion.

Qualified title, limited title and old system title 25

- This clause applies only if the land (or part of it) 25.1.1 is under qualified, limited or old system title, or 25.1
 - on completion is to be under one of those titles. 25.1.2
- 25.2 25.3
- The vendor must serve a proper abstract of title within 7 days after the contract date.

 If an abstract of title or part of an abstract of title is attached to this contract or has been lent by the vendor to the purchaser before the contract date, the abstract or part is served on the contract date.

 An abstract of title can be or include a list of documents, events and facts arranged (apart from a will or 25.4 codicil) in date order, if the list in respect of each document
 - shows its date, general nature, names of parties and any registration number; and 25.4.1
 - has attached a legible protocopy of it or of an official or registration copy of it. 25.4.2
- An abstract of title -25.5
 - it of title must start with a good foot of title (if the good root of title must be at least 30 years old, this means 25.5.1 30 years old at the confract date);
 - in the case of a leasehold interest, must include an abstract of the lease and any higher lease; 25.5.2
 - normally, needing include a Crown grant; and 25.5.3
 - need not include anything evidenced by the Register kept under the Real Property Act 1900. 25.5.4
- In the case of land under old system title -25.6
 - in this contract transfer means conveyance; 25.6.1
 - the purchaser does not have to serve the transfer until after the vendor has served a proper 25,6.2 abstract of title; and
 - each vendor must give proper covenants for title as regards that vendor's interest. 25.6.3
- In the case of land under limited title but not under qualified title -25.7
 - normally, the abstract of title need not include any document which does not show the location, 25.7.1 area or dimensions of the land (for example, by including a metes and bounds description or a plan of the land):
 - clause 25.7.1 does not apply to a document which is the good root of title; and 25.7.2
 - the vendor does not have to provide an abstract if this contract contains a delimitation plan 25.7.3 (whether in registrable form or not).
- On completion the vendor must give the purchaser any document of title that relates only to the property. 25.8
- If on completion the vendor has possession or control of a document of title that relates also to other property, 25.9 the vendor must produce it as and where necessary.
- The vendor must give a proper covenant to produce where relevant. 25.10
- The vendor does not have to produce or covenant to produce a document that is not in the possession of the 25.11 vendor or a mortgagee.
- If the vendor is unable to produce an original document in the chain of title, the purchaser will accept a photocopy from the Land Registry of the registration copy of that document.

- 26 Crown purchase money
- This clause applies only if purchase money is payable to the Crown, whether or not due for payment. 26.1
- The vendor is liable for the money, except to the extent this contract says the purchaser is liable for it. 26.2
- To the extent the vendor is liable for it, the vendor is liable for any interest until completion. 26.3
- To the extent the purchaser is liable for it, the parties must adjust any interest under clause 14. 26.4

27 Consent to transfer

- This clause applies only if the land (or part of it) cannot be transferred without consent under legislation or a 27.1 planning agreement.
- 27.2 The purchaser must properly complete and then serve the purchaser's part of an application for consent to transfer of the land (or part of it) within 7 days after the contract date.
- The vendor must apply for consent within 7 days after service of the purchaser's part. 27.3
- 27.4 If consent is refused, either party can rescind.
- If consent is given subject to one or more conditions that will substantially disadvantage a party, then that 27.5 party can rescind within 7 days after receipt by or service upon the party of written notice of the conditions.
- 27.6 If consent is not given or refused
 - within 42 days after the purchaser serves the purchaser's part of the application, the purchaser can 27.6.1 rescind; or
 - within 30 days after the application is made, either party can rescind. 27.6.2
- Each period in clause 27.6 becomes 90 days if the land (or part of li) is -27.7
 - 27.7.1 under a planning agreement; or
 - 27.7.2 in the Western Division.
- If the land (or part of it) is described as a lot in an unregistered plan, each time in clause 27.6 becomes the 27.8 later of the time and 35 days after creation of a separate folio for the lot.
- The date for completion becomes the later of the date for completion and 14 days after service of the notice 27.9 granting consent to transfer.

28 Unregistered plan

- 28.1
- This clause applies only if some of the land is described as a lot in an unregistered plan.

 The vendor must do everything reasonable to have the plan registered within 6 months after the contract date, 28.2 with or without any minor alteration to the plan on any document to be lodged with the plan validly required or made under legislation.
- 28.3 If the plan is not registered within that time and in that manner -
 - 28.3.1 the purchaser can rescind; and
 - the vendor can rescind, but only in the vendor has complied with clause 28.2 and with any 28.3.2 legislation governing the regeission.
- Either party can serve notice of the registration of the plan and every relevant lot and plan number. The date for completion becomes the later of the date for completion and 21 days after service of the notice. 28.4 28.5
- Clauses 28.2 and 28.3 apply to another plan that is to be registered before the plan is registered. 28.6

29 Conditional contract

- This clause applies only if a provision says this contract or completion is conditional on an event. 29.1
- If the time for the event to happen is not stated, the time is 42 days after the contract date. 29.2
- If this contract says the provision is for the benefit of a party, then it benefits only that party. 29.3
- If anything is necessary to make the event happen, each party must do whatever is reasonably necessary to 29.4 cause the event to happen.
- A party can rescind under this clause only if the party has substantially complied with clause 29.4. 29.5
- If the event involves an approval and the approval is given subject to a condition that will substantially 29.6 disadvantage a party who has the benefit of the provision, the party can resoind within 7 days after either party serves notice of the condition.
- 29.7 If the parties can lawfully complete without the event happening
 - if the event does not happen within the time for it to happen, a party who has the benefit of the 29.7.1 provision can rescind within 7 days after the end of that time;
 - if the event involves an approval and an application for the approval is refused, a party who has the 29.7.2 benefit of the provision can rescind within 7 days after either party serves notice of the refusal; and
 - the date for completion becomes the later of the date for completion and 21 days after the earliest 29.7.3 of
 - either party serving notice of the event happening;
 - every party who has the benefit of the provision serving notice waiving the provision; or
 - the end of the time for the event to happen.

- If the parties cannot lawfully complete without the event happening -29.8
 - if the event does not happen within the time for it to happen, either party can rescind: 29.8.1
 - if the event involves an approval and an application for the approval is refused, either party can 29.8.2 rescind:
 - the date for completion becomes the later of the date for completion and 21 days after either party 29.8.3 serves notice of the event happening.
- A party cannot rescind under clauses 29.7 or 29.8 after the event happens. 29.9

30 Manual transaction

This clause applies if this transaction is to be conducted as a manual transaction. 30.1

Transfer

- Normally, the purchaser must serve the transfer at least 7 days before the date for completion. 30.2
- If any information needed for the transfer is not disclosed in this contract, the vendor must serve it. 30.3
- If the purchaser serves a transfer and the transferee is not the purchaser, the purchaser must give the vendor 30.4 a direction signed by the purchaser personally for that transfer.
- The vendor can require the purchaser to include a covenant or easement in the transfer only if this contract 30.5 contains the wording of the proposed covenant or easement, and a description of the land burdened and benefited.

Place for completion

- Normally, the parties must complete at the completion address, which is -30.6
 - if a special completion address is stated in this contract -that address; or
 - if none is stated, but a first mortgagee is disclosed in this contract and the mortgagee would usually 30.6.2 discharge the mortgage at a particular place - that place; or
 - in any other case the vendor's solicitor's address stated in this contract. 30.6.3
- The vendor by reasonable notice can require completion at another place, if it is in NSW, but the vendor must 30.7 pay the purchaser's additional expenses, including any agency or mortgagee fee.
- If the purchaser requests completion at a place that is not the completion address, and the vendor agrees, the 30.8 purchaser must pay the vendor's additional expenses, including any agency or mortgagee fee.
- Payments on completion On completion the purchaser must pay to the vendor the amounts referred to in clauses 16.5.1 and 16.5.2, by 30.9
- cash (up to \$2,000) or settlement cheque. Normally, the vendor can direct the purchaser to produce a settlement cheque on completion to pay an 30.10 amount adjustable under this contract and (f.so.
 - the amount is to be treated as if it were paid; and 30.10.1
 - the cheque must be forwarded to the payee immediately after completion (by the purchaser if the 30.10.2 cheque relates only to the property or by the vendor in any other case).
- If the vendor requires more than 5 settlement cheques, the vendor must pay \$10 for each extra cheque.
- 30.12
- If the purchaser must make a GSTRW payment the purchaser must 30.12.1 produce on completion a settlement cheque for the GSTRW payment payable to the Deputy Commissioner of Taxation;
 - forward the settlement cheque to the payee immediately after completion; and 30.12.2
 - serve evidence of receipt of payment of the GSTRW payment and a copy of the settlement date 30.12.3 confirmation form submitted to the Australian Taxation Office.
- If the purchaser must pay an FRCGW remittance, the purchaser must -30,13
 - produce on completion a settlement cheque for the FRCGW remittance payable to the Deputy 30.13.1 Commissioner of Taxation;
 - forward the settlement cheque to the payee immediately after completion; and 30.13.2
 - serve evidence of receipt of payment of the FRCGW remittance. 30.13.3

Foreign Resident Capital Gains Withholding 31

- This clause applies only if -31.1
 - the sale is not an excluded transaction within the meaning of s14-215 of Schedule 1 to the TA Act; 31.1.1
 - a clearance certificate in respect of every vendor is not attached to this contract. 31.1.2
- If the vendor serves any clearance certificate or variation, the purchaser does not have to complete earlier 31.2 than 5 business days after that service and clause 21.3 does not apply to this provision.
- The purchaser must at least 2 business days before the date for completion, serve evidence of submission of 31.3 a purchaser payment notification to the Australian Taxation Office by the purchaser or, if a direction under either clause 4.8 or clause 30.4 has been given, by the transferee named in the transfer the subject of that direction.
- The vendor cannot refuse to complete if the purchaser complies with clause 31.3 and, as applicable, clauses 31.4 4.10 or 30.13.
- If the vendor serves in respect of every vendor either a clearance certificate or a variation to 0.00 percent, 31.5 clauses 31.3 and 31.4 do not apply.

- 32 Residential off the plan contract
- 32.1 This clause applies if this contract is an off the plan contract within the meaning of Division 10 of Part 4 of the Conveyancing Act 1919 (the Division).
- 32.2 No provision of this contract has the effect of excluding, modifying or restricting the operation of the Division.
- 32.3 If the purchaser makes a claim for compensation under the terms prescribed by sections 4 to 6 of Schedule 3 to the Conveyancing (Sale of Land) Regulation 2022
 - 32.3.1 the purchaser cannot make a claim under this contract about the same subject matter, including a claim under clauses 6 or 7; and
 - 32.3.2 the claim for compensation is not a claim under this contract.

ADDITIONAL SPECIAL CONDITIONS

33. Alterations to printed form

- 33.1 Clause 7.1.1 is amended to delete reference to 5% and replace with \$1.00.
- 33.2 Clause 18 is amended by adding the following clause 18.8 "The purchaser cannot make a claim or requisition or delay settlement after entering into possession of the property".
- 33.3 Clause 25.1.1 is amended to delete reference to the words "limited".
- 33.4 Clause 25.2 is amended to delete reference to 7 days and replace with 21 days.
- 33.5 Clause 25.7 is deleted.
- 33.6 Clause 25.10 is amended by deleting the words "the Registrar-General of the registration copy of that document." and inserting the words "the Vendor of a copy of that document provided by NSW Land Registry Services".
- 33.7 Clause 29 of this contract is deleted.

34. Agreement between vendor and purchaser

It is expressly agreed between the purchaser and the vendor that all of the conditions of sale are embodied in this agreement and the vendor shall not be liable to the purchaser for any agreement, stipulation, condition, statement or representation made by any other person or agent acting or purporting to act on behalf of the vendor in relation to the property its state of repair or suitability for any purpose whatsoever except as expressly set out in this agreement.

35. Caveat

The purchaser is not entitled to lodge and register a Caveat against the property without the prior written consent of the vendor.

36. Certificate under Section 10.7(2) – 10.7(5) Environmental Planning & Assessment Act

Should a Certificate under Section 10.7(2)-10.7(5) of the Environmental Planning and Assessment Act 1979 be applied for and the Local Council refuses to issue such a Certificate or imposes any conditions with which the vendor is unwilling to comply as a pre-requisite to the issue of such a Certificate, then the purchaser may rescind this agreement but shall not have any other remedies.

37. Completion

Completion shall take place on the completion date, being no later than 5.00pm on that day. If completion has not taken place on or before such date, either party hereto, not being in default hereunder, may give to the other fourteen (14) days' notice in writing to complete and such notice shall thereupon make such time of the essence of this agreement. The party to whom such notice is given shall not be entitled to

object to the sufficiency or adequacy of such notice. Any Notice to complete issued under this Contract may be withdrawn or extended at any time by further written Notice given by the party that issued the Notice.

In the event the vendor issues to the purchaser a Notice to Complete, the purchaser shall pay to the vendor, on settlement, by way of liquidated damages the sum of \$330.00 inclusive of GST, and payment of this amount is an essential term of this Contract for Sale.

38. Death, mental illness or bankruptcy of parties

Notwithstanding any rule of law or equity to the contrary, if either party prior to completion: -

- 38.1 Dies or becomes mentally ill or incapacitated then either party may by notice served upon that party, rescind this Contract for Sale and such rescission shall be a rescission pursuant to Clause 19; or
- 38.2 Be declared bankrupt or enter into any scheme or make any assignment for the benefit of creditors or being a company, resolve to go into liquidation or have a petition for its winding up presented or enter into a scheme of arrangement with its creditors, or should a liquidator, receiver or official managed be appointed in respect thereof, then that party shall be deemed to be in default hereunder and the other party shall be at liberty to exercise all or any of its rights conferred under this Contract for Sale.

39. Deposit less than ten percent

The Purchaser acknowledges that the deposit payable hereunder is ten per cent (10%) of the purchase price. If the vendor on the making of this Contract agrees that the deposit may be paid by instalments, then notwithstanding any other provision of this Contract, the Purchaser shall pay the deposit by instalments as follows:

- 39.1 the sum equivalent to 5% of the deposit to be paid on or before the date of this Contract in accordance with clauses 2.1 and 2.2 of the printed Contract; and
- 39.2 the balance of the deposit on or before completion of this Contract and the provisions of clause 2.3 shall apply.

The parties hereto acknowledge that the agreement to pay the deposit by instalments is part of the consideration for this Contract.

40. GST

In the event of this sale being liable for GST (despite the notations in this contract to the contrary) then such GST shall be payable by the purchaser and the parties agree that the vendor may apply the margin scheme to the supply of the property; and notwithstanding the provisions of clause 13.10, the vendor must give the purchaser a tax invoice for the taxable supply within three (3) months of this sale being determined to be a taxable supply

41. Interest for non-completion by purchaser

If through no fault of the vendor, the purchaser does not complete this contract on the Completion Date, then, and without prejudice to all other remedies of the vendor, the purchaser shall pay to the vendor in cash on completion, an amount being interest calculated on the balance of the purchase monies as at the date of exchange payable hereunder at the rate of eight per centum (8%) per annum in respect of the period commencing from the completion date under the Contract and up to and including the date the Purchaser completes the Contract and it is an essential term of this contract that such interest be so paid.

42. Present State of Condition & Repair

The subject property land and improvements are sold in their present state of repair and no warranty as to their condition is given by the vendor and the purchaser will not raise any requisition or objection or make any claim for compensation on the grounds that there are any latent or patent defects in any building or structure erected upon the subject property or that any repairs are required thereto.

43. Release of Deposit

In the event that the vendor is proposing to purchase another property and requires the deposit referred to in the front page of this contract to be released, then the purchaser hereby authorises the release of such deposit provided that the deposit is to be placed in the Trust Account of the Real Estate Agent of the vendor's Licensed Conveyancer or Solicitor in such subsequent purchase.

44. Requisitions on Title

- 44.1 The purchaser acknowledges that the only form of Requisitions on Title that shall be raised pursuant to clause 5 are the Requisitions on Title annexed to this Contract for Sale; and
- 44.2 Nothing herein contained shall prohibit the purchaser from raising a specific requisition arising out of any matter under this contract.

45. Septic System

Should there be a septic system located on the property then the purchaser accepts it in its present state of repair and condition. The purchaser may not make any claim, objection, or requisition, delay completion or rescind or terminate this contract because of the state of repair, condition or presence or absence of Council approval to operate the said septic system.

46. Survey Report

In the event a Survey Report relating to the property is annexed to this Contract for Sale discloses any encroachment by or upon the property and/or non-compliance with the *Local Government Act*, the purchaser shall not be entitled to make any requisition, objection or claim for compensation in relation to such encroachment and/or non-compliance. The purchaser further acknowledges that the vendor makes no guarantee that the original copy of the Survey Report annexed to this Contract for Sale will be available on settlement.

47. Vendor's Agent

The purchaser warrants that he was not introduced to the property by way of any real estate agent other than the vendor's agent (if any) referred to as the 'Vendors Agent'. The purchaser is liable for any commission payable by the vendor as a result of a breach of the warranty. The parties agree that the obligations under this clause will not merge on completion.

48. Water Meter Reading

- 48.1 The purchaser may arrange to have a meter reading undertaken by the governing water authority to ascertain water usage up to the date of completion and the vendor will pay for such water usage to the date of completion.
- In the alternative the vendor and the purchaser may agree to adjust the water usage charges on the basis of any estimate of water usage charges calculated in accordance with the average daily consumption for the last meter reading period as advised by the governing water authority and such adjustment shall be final and conclusive and no further adjustment of water usage charges shall take place after completion.

49. Foreign Investment Review Board

- 49.1 The Purchaser warrants that the provisions of the *Foreign Acquisitions & Takeovers Act 1975* (Cth) do not apply to the Purchaser or this purchase.
- The Purchaser hereby indemnifies the Vendor against any action, claim, cost, charge, damage, expense, liability, loss, outgoing or payment which the Vendor suffers as a result of a breach of the warranty contained in Clause 49.1.
- 49.3 This clause shall not merge on completion.

50. Aboriginal Objects and Artefacts

The Vendor discloses that the Section 10.7 Planning Certificate annexed to this Contract for Sale may not disclose the history or presence of Aboriginal objects and artefacts, whether latent or patent, on the property. The Purchaser acknowledges this disclosure made by the Vendor and the Purchaser shall make and rely upon their own enquiries, inspections and reports in this regard. Further, the Purchaser acknowledges they shall not be entitled to rescind this Contract, make any claims, objection, requisitions or serve a Notice on the basis of the history or presence of Aboriginal objects and artefacts on the Property.

51. Electronic signatures

The parties acknowledge that in the event signatures which are facsimile, photocopy or any other form of electronic signature by either the Vendor or Purchaser are acceptable for the purposes of exchange. The Parties agree to provide to the other party the signed Contract bearing original signatures within seven (7) days after the date of this Contract. The signed Contract bearing original signatures is to be dated the same date as this Contract. The parties shall not be make any requisitions, objection, claim or delay completion due to the exchange of Contracts taking place in accordance with this Clause.

RESIDENTIAL PROPERTY REQUISITIONS ON TITLE

Possession and tenancies

1. Vacant possession of the property must be given on completion unless the Contract provides otherwise.

2. Is anyone in adverse possession of the property or any part of it? 3.







Whether an order has been made under the Trees (Disputes Between Neighbours) Act 2006 to carry out work in relation to a tree on the land, but only if the council has been notified or the order.

Council has NOT received notification from the Land and Environment Court of NSW that the land is affected by an Order under Trees – (Disputes Between Neighbours) Act 2006.

## ITEM 19 - Annual charges under Local Government Act 1993 for coastal protection services that relate to existing coastal protection works

If the *Coastal Management Act 2016* applies to the council, whether the owner, or a previous owner, of the land has given written consent to the land being subject to annual charges under the *Local Government Act 1993*, section 496B, for coastal protection services that relate to existing coastal protection works.

The owner (or any previous owner) of the land has NOT consented in writing to the land being subject to annual charges under section 496B of the Local Government — Act 1993 for coastal protection services that relate to existing coastal protection works (within the meaning of section 553B of that Act).

**Note** - In this section existing coastal protection works has the same meaning as in the Local Government Act 1993, section 553B.

**Note –** Existing coastal protection works are works to reduce the impact of coastal hazards on land, such as seawalls, revetments, groynes and beach nourishment, that existed before 1 January 2011

#### ITEM 20 - Western Sydney Aerotropolis

The State Environmental Planning Policy (Precincts – Western Parkland City) 2021 does not apply to land within the Maitland City Council local government area.

#### ITEM 21 - Development consent conditions for seniors housing

If State Environmental Planning Policy (Housing) 2021, Chapter 3, Part 5 applies to the land, any conditions of a development consent granted after 11 October 2007 in relation to the land that are of the kind set out in that Policy, section 88(2).

Clause 88(2) of the *State Environmental Planning Policy (Housing) 2021* restricts occupation of development approved for seniors housing to:

- a) Seniors or people who have a disability
- b) People who live in the same household with seniors or people who have a disability,
- c) Staff employed to assist in the administration and provision of services to housing provided under this Part.

## ITEM 22 - Site compatibility certificates and development consent conditions for affordable rental housing

Whether there is a current site compatibility certificate under State

Environmental Planning Policy (Housing) 2021, or a former site compatibility certificate, of which the council is aware, in relation to proposed development on the land and, if there is a certificate –

- a) the period for which the certificate is current, and
- b) that a copy may be obtained from the Department.

If State Environmental Planning Policy (Housing) 2021, Chapter 2, Part 2, Division 1 or 5 applies to the land, any conditions of a development consent in relation to the land that are of a kind referred to in that Policy, section 21(1) or 40(1).

Any conditions of a development consent in relation to land that are kind referred to in State Environmental Planning Policy (Affordable Rental Housing) 2009, clause 17(1) or 38(1).

Note - No Seniors Housing development consent conditions apply to this land.

**Note -** In this section – Former site compatibility certificate means a site compatibility certificate issued under State Environmental Planning Policy (Affordable Rental Housing) 2009.

Council is unaware if a Site Compatibility Certificate (Affordable Rental Housing) has been issued in accordance with State Environmental Planning Policy (Affordable Rental Housing) 2009.

Note. The following matters are prescribed by section 59(2) of the Contaminated Land Management Act 1997 as additional matters to be specified in a planning certificate.

#### Contaminated Land

- a) The land to which this certificate relates is NOT significantly contaminated land within the meaning of the Contaminated Land Management Act 1997.
- b) The land to which this certificate relates is NOT subject to a management order within the meaning of the Contaminated Land Management Act 1997.
- c) The land to which this certificate relates is NOT the subject of an approved voluntary management proposal within the meaning of the Contaminated Land Management Act 1997.
- d) The land to which this certificate relates is NOT the subject to an ongoing maintenance order within the meaning of the Contaminated Land Management Act 1997.
- e) Council has NOT been provided with a site audit statement, within the meaning of the Contaminated Land Management Act 1997, for the land to which this Certificate relates.


